Hochstraser murder trial update

FORMER DE ANZA STAFFER CHARGED WITH MURDER APPEARS IN COURT

LA VOZ STAFF REPORT

Former De Anza College staff member Alexandre Hochstraser made a brief court appearance Wednesday at the Hall of Justice in downtown San Jose.

Hochstraser was arrested in June of 2005 for the murder of his live-in girlfriend, Mission College employee, Dolores Gonzales.

At 9:45 p.m. on June 5, 2005, Santa Clara Police received a call regarding "suspicious circumstances" at the apartment.

Hochstraser was arrested after police discovered a dismembered human body, later identified as

Gonzales, in large plastic storage tubs in the couple's red Volkswagen Jetta parked at the apartment complex.

According to search warrants, police gathered evidence indicating that Gonzales' body was cut up in the shower in the couple's apartment. Police seized the shower drain system during their investigation.

Officers reported smelling bleach in the apartment and found saw blades on the kitchen table, as well as Gonzales' fanny pack with her identification and keys. Police also found a receipt for plastic storage bins and a human model with the limbs removed.

According to police reports, Hochstraser and Gonzales had an argument that turned physical the previous night. A relative of Gonzales called police after her family was unable to reach her the next

Hochstraser plead not guilty to one count of murder later that month.

In May, a taped phone call, believed to be a conversation between Hochstraser and his mother, was presented in court. "I killed Dolores," the man on the tape said.

Hochstraser is scheduled to appear again at San Jose's Hall of Justice on Oct. 23 at 9 a.m. in courtroom 24. The Hall of Justice is located at 190 West Hedding Street in San Jose.

The first issue of the De Anza College student newspaper (then known as "De Anza College Vistas") published on Sept. 11, 1967, boasted of De Anza's ambitious plans for the winery. According to the article, the winery was to include, a "coffee shop and bookstore, [which] will be connected by an underground tunnel to the multi-level Campus Center."

Construction inside the winery as well as the building of underground tunnels was expected to be completed in February of 1968, according to the article.

In what appears to be a costsaving measure, two letters in the bookstore sign have been changed to read "Foodstore."

De Anza's Insider magazine offers student guide to the campus

Insider magazine, a students' guide to the people and places of De Anza College, is now available on campus newsstands.

The 72-page magazine was produced by De Anza College's journalism program.

It was designed to be a fun introduction to the campus for new students, and entertainment for De Anza's old-timers.

Reza Kazempour, who was the publisher of Insider, said he enjoyed spending time in the summer to produce the magazine.

Kazempour gained experience in journalism at De Anza while a staff writer and managing editor of the campus newspaper, *La Voz*. Although working for *La Voz* helped Kazempour lead the magazine staff, he said that working on Insider was a different experience.

"The magazine was pretty cool because it gave me a lot of freedom to do what I wanted. With the newspaper, your role is very limited in terms of what your assignment is."

In addition to the printed magazine, Insider also has a companion Web site, www.DeAnzaInsider.com, that will feature videos and articles not printed in the magazine.

The staff of Insider decided

early in production that they wanted to keep the tone of the magazine upbeat and positive. Before production began, they decided to drop two stories that they felt were too serious.

One story was about Al De-Guzman, a former De Anza student who was convicted in 2002 of planning a shooting spree on campus.

The other proposed story dealt with Alexandre Hochstraser, a former De Anza staff member who is on trial for murder.

"[The stories] just felt out of place," Kazempour said.

Copies of the magazine were shipped to De Anza last Friday, so that they would be on campus in time for the first day of classes.

Students who were interested in being on the magazine staff signed up for Journalism 61 during the summer quarter.

Since La Voz does not publish during the summer, the magazine class was able to use the Journalism department facilities during the newspaper's hiatus.

Although members of the magazine staff told *La Voz* that being on the Insider was a positive experience, the magazine did hit a few snags along the way.

As the deadline to send the magazine to the printing press approached, it was uncertain where funds for the production would

come from.

"Fortunately, I was able to sell enough advertising to the Financial Aid Office to pay for most of the printing," Kazempour said. "Cindy Castillo, the director, was very supportive."

The second edition of the Insider magazine is the third student magazine that has been produced by the Journalism department. In the summer of 2003, students produced "La Guia" (Spanish for "The Guide").

La Guia offered articles ranging from how to be successful at De Anza to what bathrooms students should avoid on campus.


In the summer of 2005, students in the Journalism department collaborated again and produced a magazine.

This time, the staff called their magazine "Insider" and dubbed it "The Ultimate Students' Guide to De Anza College."

Last year's Insider featured 48 pages printed on glossy paper, giving it a more professional look than La Guia.

Members of last summer's magazine staff are already looking forward to creating an issue next summer.

"I'm happy that we're done," Kazempour said. "I hope that the team can come togethr again next summer to publish the Insider once again."



Dear EarthTalk: What environmental impacts should our community expect if we allow Wal-Mart to open up a store nearby?

With more than 6,000 stores spread out across the globe--Wal-Mart is the world's biggest retailer, hands down, and also a magnet for criticism for its low wages, inadequate health coverage and effect on struggling downtowns. Wal-Mart has also had its share of environmental problems.

Environmentalists complain that the company's stores--often on the outskirts of rural communities--eat up open space, replacing farms and forests with concrete and pavement. And the company has been fined repeatedly in recent years by various agencies for environmental negligence. For example, in 2005, Wal-Mart paid \$1.15 million in fines to the state of Connecticut for the improper storage of pesticides and other toxins that polluted streams near its stores there, according to the website WakeUp-WalMart.com.

A year earlier, Florida fined the company \$765,000 for violating petroleum storage tank laws at its auto service centers. The company admits that it failed to register its fuel tanks and to install devices that prevent overflow, and that it did not perform monthly monitoring, and that it blocked state inspections. That same year, Georgia fined Wal-Mart \$150,000 for contaminating water outside of Atlanta.

And the U.S. Environmental Protection Agency penalized the company \$3 million in 2004 for violating the Clean Water Act in nine states. The company was also forced to change its building practices so as to prevent future water contamination. This came on the heels of a \$1 million fine for Clean Water Act violations at 17 locations in four other states. Wal-Mart also agreed to establish a \$4.5 million environmental management plan to improve its compliance with environmental laws at construction sites.

Wal-Mart says that change is afoot within the company. CEO Lee Scott has said that sustainability in all its forms is a key concern moving forward. "As one of the largest companies in the world, with an expanding global presence, environmental problems are our problems," Scott told company employees last October.

Scott's green vision includes powering facilities and fleet with renewable energy, cutting back on waste, and selling green products. Wal-Mart reportedly crafted their greening plan with the help of former Vice President Al Gore. Commitments include reducing greenhouse gas emissions by 20

percent at existing locations 20 percent, and investing \$500 million in environmental improvements each year moving forward.

Wal-Mart is also reportedly ramping up plans to offer organic produce and using local farms to save transportation costs. According to Ron McCormick, an executive in the company's produce division, Wal-Mart is already buying a wide variety of produce based on what's available in each region, instead of shipping produce across the country. "Our whole focus is: How can we reduce food-miles?" he says.

The green attitude also extends to other products, with the company increasing offerings of sustainably harvested fish and organic cotton clothing and bedding. Critics say Wal-Mart is so focused on profit that such efforts will never stick. Only time will tell if Scott's vision for a greener Wal-Mart becomes reality.



New book tells tales of shacking up at Hef's Playboy mansion

The parties. The girls. The sex. The legend. These things come to mind when Hugh "Hef" Hefner, the founding father of "Playboy," is mentioned.

In chapters such as "The Blonde Boob Brigade" and "Play mates at Play," former live-in girlfriend Izabella St. James discusses all of these and more in her tell-all book, "Bunny Tales: Behind Closed Doors at the Playboy Mansion."

In a recent press interview with the Toronto Star, St. James discussed her decision to write her book. "I didn't want to kiss and tell," she insisted. "But our society is absolutely fascinated by sex. I'm giving them what they want to hear."

It was at her second year at Pepperdine when St. James had a chance encounter with Mr. Playboy himself, "Hef," at a Los Angeles nightclub. After meeting Hefner, she would eventually move into the Playboy mansion.

She notes, "That night, although I didn't know it, I was being recruited."

In the book, St. James chronicles her life and the seduction of Playboy, and her eventual moving into the mansion, where she lived for almost three years. She was one

of the infamous seven girlfriends, before his now-established trio of blondes. Her storytelling approach is very matter-of-fact, from the detailed mansion layout, to the chronological order of his revolving door of girlfriends.

No doubt, she is very aware of her audience. She teases, "You probably want details, don't you?" and then delivers.

Does Hefner really sleep with all his girlfriends? In a word, yes.

In the chapter entitled, "How to Make Love like a Rabbit," St. James describes the unconventional sexual routine that goes on in the master bedroom.

Sexual acts were a spectator sport, with multiple women and, of course, one man.

According to St. James, it was all a routine, from the beginning to end of the orgies. She says that there were actually designated days of the week for sex.

St. James claims to have written this book so that she "could finally set the record straight." However, this is clearly a cautionary tale. She wishes to debunk all the rumors of grandeur and excess, and expose the mundane reality of living in the mansion and being Hefner's girlfriend.

She stresses the catfights, the lack of privacy, and how "there are too many unwritten rules, too

many power plays, and everyone acts." St. James reveals some surprising details, such as the strict 9 p.m. curfew, and the fact that Hefner does not actually own the mansion but rents it.

In the book, it's clear that that she viewed other girls who came in and out of the mansion as beneath her. St. James says she was the "token smart girl that validated the group in an intellectual way."

Her apparent goal is to have the audience sympathize with her, which we can at some points, but other times readers may wonder why she stuck around for as long as she did.

If she so detested the lifestyle she was living, then why did she get a Playboy bunny tattoo?

She does seem hypocritical at times, quick to mention Hefner's negative traits, but at the same time, lovingly writes how he is such a "good person."

If you wish to hold onto the allure and mystique of Hefner, and all things Playboy, then this book is not for you. Her apparent goal is to kill all the daydreams and fantasies that Playboy and Hefner have to offer.

If you hold a deep curiosity, and enjoy watching the e! television series, "The Girls Next Door," this will be a delicious read.

Anna Callahan and DeSeabra survive impeachment attempt



> Tony Suen and Yessenia Ramirez win election



An overlooked sport: Instructor gets physical with 'jazz dance'

"There is nothing unusual about me, to me!" says Warren "Juba" Lucas, head of the dance department at De Anza College.

He was born and brought up in Brooklyn, New York with two brothers and one sister. When he announced he was joining the North Carolina Dance/Theatre, a professional regional touring company, his mother said, "All this is fine but when are you going to get a job?"

Lucas began dancing as a high school student in New York with the Ron Davis Dancers, where he performed with jazz music giants Jimmy Smith and Mary Lou Williams. He performed at Carnegie Hall with Oliver Nelson and his orchestra, and toured Mexico for the State Department with Thad Jones and Mel Luis.

He received a Bachelor of Fine Arts degree from the North Carolina School of Arts, and a Master of Arts from the University of California, Los Angeles. He danced in Hollywood for ten years and appeared in a dozen national and international television shows. He was in "The Prince and the Pauper" with Ringo Starr,

"Hollywood's Diamond Jubilee," and "Just Plain Cher." He worked with top choreographers Jaime Rogers, Allen Johnson, Joe Layton and Donald McKayle.

Lucas worked as a night club performer, appearing with Lola Falana, Dionne Warwick, Juliet Prowse and Denice Williams. He was in pop music videos with Weird Al, The Weather Girls, Klymax and Thelma Housten, sometimes acting as choreographer as well. His favorite dancer is Paul

Pushing his long locks behind, which he says, "is less expensive than a haircut," he strides the floor of the dance studio with snaps, claps, swirls and swings. His light frame and toned muscles are a cause of envy for many of his young students.

Lucas has traveled internationally and performed extensively in Europe. He would like to see Africa and Asia. Given a chance to live his life over again, he says he would learn to build things with his hands. During his leisure, he cares for bonsai plants.

Teaching ballet, contemporary dance and jazz gives his body a total aerobic workout, and cycling completes his exercise routine.

Muslims, media distort pope's true intentions

One cherry-picked quote taken out of context can destroy reason, and Pope Benedict XVI is learning that the hard way now.

In a speech he gave at Regensburg University, where he taught theology from 1969 to 1977, the pontiff spoke about how Christianity is tightly linked to reason and that God's nature was in reason. Therefore those who act without reason are acting contrary to the nature of God.

The pope quoted Emperor Manual II Paleologos, a 14th century Byzantine emperor, from his dialogue with a Persian scholar on the truths of Christianity and Islam.

The emperor touches on the theme of the Islam jihad (holy war) making the central question on the relationship between religion and violence with these words from Manual II.

The pope quoted, "Show me just what Mohammed brought that was new, and there you will find things only evil and inhuman, such as his command to spread by the sword the faith he preached."

This is the quote that has enraged the Muslim world. Muslim fanatics, egged on by the media, have come out of the woodwork and demanded the pope's head on a silver platter. A Turkish lawmaker compared Pope Benedict to Hitler and Mussolini. The Mujahideen's Army movement in Iraq has targeted the pope for a suicide attack. A Somalian cleric has called for Muslims to hunt down and kill the pope. Al Qaeda militants have declared war on "worshippers of the cross."

Television news has broadcasted images of protestors burning an effigy of the pope in Basra. Muslims extremists in Cairo, Egypt firebombed five churches in the Palestinian territories. Of course, let's not forget Sister Leonella Sgorbita, the nun who many speculate was killed in retaliation for the pope's comments.

It's nice to see that Islam has progressed so much since the 14th century. Emperor Manual II Paleologos would feel right at home as if nothing has changed since his time.

What people keep missing is that the comments that caused this controversy were the emperor's words — not the opinion of Pope Benedict. The pontiff simply quoted the emperor to show that religious conversions through violent means are not reasonable and are contrary to the nature of God. But the problem is that radical Islam has always given the world only two choices: convert or die.

We were reminded once again of this in August when two Fox News journalists, Steve Centanni and Olaf Wiig were kidnapped in Gaza by a Muslim terror-

ist group. The two men were forced at gunpoint to declare that they have converted to Islam.

What is ironic about the whole pope controversy is that Benedict XVI's speech was meant to inspire peaceful, interfaith dialogue, and to speak against all types of violent, religious fundamentalism. But that doesn't fit well into a 30 second sound bite.

Pope Benedict has noble goals. He wants to initiate a dialog with both Christian and Muslim leaders.

He wants to see them work through their basic fundamental differences and inspire both sides to become closer together as worshipers of God.

But, instead, the pope ran into an iceburg that's now trying to sink his ship. The quote that caused the pope so much grief was only two lines out of an eight page speech.

The lines were purposely picked out to make large blaring headlines by people that have no love for God or the religions that worship him.

So, for the sake of media sensationalism, we get a dead nun, firebombed churches, death threats, and the threat of a religious war.

It's nice to see journalistic integrity in full swing. The media took a quote from a speech out of context and then demanded an apology from the very person who they misrepresented.

The pope has tried to apologize to anyone who was hurt by his comments, but his apology has not been accepted.

Instead, extremist violence and animosity on both sides have continued — which was what Benedict XVI was trying to put and end to.
