Budget deficit affects De Anza

The Foothill-De Anza Community College District is facing its worst financial crisis since 1979. An external audit of the district's budget recently uncovered a budget deficit between 3.5 and 3.8 million dollars.

Budget Chief Jack Mason predicted a \$6,135,000 general fund for the District at the end of the fiscal year. However, when Mason could not account for the missing millions, he submitted his resignation.

Chancellor Tom Fryer called an emergency meeting on Monday, April 8 to discuss a number of errors that were found in the financial statements of the District Board. The findings uncovered the extent of the financial woes facing the Foothill-De Anza Community College District. The Board will have to cut \$7 million from the District budget by June 30.

"No one is quite sure where the errors came from at this moment," said Teo King, DASB Vice President of Finance.

"We're just clear that there are significant problems."

As a result of the budget crises, the District Board ordered a freeze on non-faculty hiring and most De Anza classroom supplies and expenditures. The Board is in the process of laying off a number of non-faculty and part-time employees, but they have the option to re-hire only a number of employees on July 1 depending upon the amount of funds. Student workers of the Learning Center, Bookstore, Security, and numerous other programs were also layed off without any prior notice.

According to the Dean of Language Arts, Don Barnett, the worst scenario would result in layoffs of part-time and full-time faculty members. The deficit came as a surprise to Barnett.

"The way it looks on paper gives the impression of us being stupid, careless, and naive," said Barnett. "I'm embarrassed."

However, the budget shortfall will not result in a tuition raise due to a state law prohibiting any tuition increase for any community college.

Burglars elude De Anza security staff

Between the hours of 9:30 p.m. on March 26 and 9:55 a.m. the following morning, four pieces of video equipment were stolen from room L42.

The loss was estimated at \$2,800, which included: a TV, VCR, camcorder, and its tripod. The equipment was used for a class on public speaking taught during the winter quarter. New video equipment for the class has been replaced from other departments on campus.

The equipment was stored in a cabinet in room L42, which was forced open sometime during the period of time when

the room is left unlocked for cleaning. The room is sometimes unlocked for about an hour after the last class and for a simular amount of time before class in the mornings.

"Seems like someone's always one step ahead of us," commented De Anza's Director of Security, Michael Paccioretti. Aside from alarm systems in some of the rooms, storing the video equipment in a cabinet was the only thing preventing the theft from occurring. To further reduce the chance of theft on campus, most video equipment will now be locked down by cable locks.

The burglary, case # 91361, was one of

approximately four or five cases of campus theft that occur per year. Paccioretti hopes to reduce this number to

No one has yet been arrested or detained for the burglary. It is believed to have been an inside job. Ninety-five percent of the thefts in places of business nationwide are believed to be internal thefts. Paccioretti considers De Anza a business in this sense. Seventeen of the buildings on the De Anza campus are equipped with alarm systems. These buildings are generally the ones that hold the computer equipment for the school. However, room L42 is not one of these.




Do The Right Thing provokes project

What do you get when you combine four De Anza English teachers, over one hundred and forty students, and one socially conscious movie? You get a rewarding teaching experience from both sides of the desk, and a large packet of letters addressed to Spike Lee, detailing what students thought about the movie Do The Right Thing.

During the fall quarter of 1990, English instructors Kate Hunter, John Lovas, Alan Simes, and Randy Splitter decided to combine their English/Writing 1A classes for a different kind of learning experience.

Throughout the quarter, their classes met and worked together on various kinds of projects. The final and most important collaboration occurred when the students were shown the Spike Lee movie, Do The Right Thing.



For those who haven't seen Do The Right Thing, the story takes place on the hottest day of the summer in Bedford-Stuyvesant, a predominantly black neighborhood in Brooklyn.

The action centers around an Italian owned pizzeria. Throughout the day, the temperature and the tempers rise, and as the humid twilight falls, the racist feelings that have been quietly boiling all day explode. There is a riot, during which a black man is killed by white police officers.

That's a fairly simplistic

explanation of the movie, but if serious," to "This movie only you haven't seen it, the tension and interaction between the races is hard to explain.

After the classes saw the movie, the students participated in discussions, trying to answer questions such as "What does it mean to be doing the right thing?" Students also discussed how the themes of the movie (Violence, Racism, Justice, and Personal Responsibility) were portrayed and whether or not they agreed the portrayals were accurate. The project culminated with every student writing a letter to Spike Lee. The letters were consolidated into a packet, and sent off with a cover letter, written by the four instructors, to Spike Lee.


Completely unedited by the teachers, the letters say everything from, "You've opened my eyes, I never realized that the problem of racial injustice was so

encourages racial tension among races."

The cover letter of the packet sent also contained an open invitation to Spike Lee, asking him to speak at De Anza college. As of yet, there hasn't been an answer, but be assured that Spike Lee will realize that he would be doing the right thing by coming to speak at De Anza.




