### Another UC drops its TAG program

UC San Diego officials recently announced the college will no longer participate in the Transfer Agreement Guarantee program.

For years, California community colleges students have been able to sign a TAG agreement that guarantees admission to a specific University of California school. But many universities, such as UC Berkeley and UCLA, are no longer participating in this arrangement.

According to UT San Diego website, UCSD campus officials opted out of the TAG agreement because, "explosive growth in the number applications under the program, coupled with sharp cuts in state funding for the University of California, have threatened to swamp the campus."

As well, strong eligible transfer applicants who did not apply through TAG were being rejected said Penny Rue, vice chancellor for student affairs at UC San Diego, in an interview with the

San Diego Union-Tribune.

"There is a fundamental question of fairness to all qualified applicants," Rue said. "Is it fair to guarantee admission to these students when we're turning away transfer students with 3.7 GPAs?"

In 2012, the UC system limited students to one TAG application. The hope was to decrease the high demand of applicants. But the demand for UCSD did not decrease.

The recent announcement alarmed many students, who are now worried their TAG applications may be void with the new policy in place.

Patricia Gibson, De Anza College transfer center coordinator, said students who already have an outstanding UC San Diego TAG application don't need to worry. But TAG agreements are no longer available starting fall quarter 2014.

"The largest portion of students that get accepted, get accepted without using a TAG," Gibson said. "Don't be discouraged if you don't have the TAG as an option."

### NCAA tougher transfer requirements may affect De Anza students

Collegiate National Athletic Association has recently requirements changed the for athletes to emphasize the importance of education along with sports.

"The minimum required GPA is now 2.5 instead of 2.0," said De Anza College Athletic Academic Advisor Matt Trosper.

Division I schools will only accept two units of PE toward a player's GPA to transfer. This no longer allows students to take unlimited classes in the PE category Trosper said.

Even though these changes could challenge student athletes more academically, it could keep them more focused in order to


attain the 2.5 GPA.

All of these new requirements are in effect for the current period for transfer students.

Division II schools are also going to change their prerequisites, but those will not be in effect until August 1, 2016.

The new requirements include a minimum 2.2 GPA and a limit of two credits of PE.

Other changes involve 12 semester or 12 quarter-hours of transferable degree credits per term, which must include six or eight hours of English, three semester or four quarter hours of math and three semester or four quarter hours of science, according to Competition Requirements for a Division II Two-Year College Transfer.



Susan Cheu was named vice president f office of finance and college operations for De Anza College effective Sept. 2.

Cheu is: the chief finance and budget officer, responsible for budget and personnel, college operations, emergency preparedness, Measure C and E and sustainability such as the bookstores and the cafeteria, according to the De Anza's website

"At this point I am still learning about the school and figuring out how things are working and what is going on, that is really my focus," Cheu said in an interview.

Letha Jeanpierre, former vice president of finance and college operations, said Cheu comes with a lot of experience. "All I have to do is to tell her things that are unique to De Anza," she said.

Jeasnpierre and Cheu have worked together in the past.

"Working in the community college system shows me the change I can make in people's

lives. That is just so dramatic," Cheu said.

Challenges await Cheu but said she is ready and excited to face them head on.

"I am really excited to be here, obviously it's a much larger school than Gavilan is," Cheu said. "Different things are going on here, different population emphasis."

She also mentioned she was impressed by the energy of the students and faculty.

"There are wonderful and exciting things being done here."

Before joining De Anza College, Cheu completed her postgraduate degree in accounting at SJSU. She served six years at Gavilan College first as the director of business services and then as interim chief financial officer.

As well, Cheu was a member of the college's employee-employer relations committee and oversaw the financial resources portion of Gavilan's most recent accreditation self-study.

# DASB Senate allocates money to baseball, badminton

The DASB senate allocated a total of \$8,500 to De Anza College sports teams during its meeting on Wednesday, Oct. 1.

\$6,100 was given to the baseball team for travel expenses and a new pitching machine.

The travel expenses, totaling \$2,000, were unanimously approved without debate.

The pitching machine, \$4,100, was debated before the funds were finally approved.

"\$4,100 is a lot seeing as how we have \$17,000 for this quarter," said senate member Pedro Alberto Enriquez.

Senate member Rhea Goveas defended the purchase.

"It is a one-time thing that will last a long time," she said.

The women's badminton team requested, and was granted, \$2,400 to cover travel expenses.

The senate approved member Hakwoo Kim as the legislative affairs officer. The legislative affairs officer serves as the DASB Senate's liaison to several state level groups. Kim said his goal is to help make higher education more accessible and affordable for students.

"It's hard for students to get into higher education due to financial issues," Kim said.

The meeting ended with a lecture by Director of College Life and DASB Senate Adviser John Cognetta on California's Brown Act.

The Brown Act is a set of laws that require elected public groups, such as the DASB senate, to hold their meetings in a public and open manner.

### App Review:

### Sleepio: More work than ZZZs?

Sleepio is a 3.5 rated sleep improvement app that, according to the iPhone app store, promises to help you fall asleep 50 percent faster, reduce time spent awake at night by up to 60 percent and boost daytime energy by up to 50 percent.

For those De Anza College students who have children or jobs on top of taking college courses, sleep deprivation can be so common it has become unnoticeable.

Sleepio seems like the perfect solution.

When you open the app, you are automatically starting your

free seven day trial, which then becomes \$149 for 12 weeks.

You must first create a sleep profile with the help of Le Profe, an animated man wearing a suit and tie who helps determine what areas of your everyday life are

affecting your sleep.

There are about 10 questions per section, including what kind of troubles you have sleeping, how many days a week you have these troubles and what you think about while laying in bed; all of these are narrated by Le Profe.

Once your profile is complete, you are graded in three criteria: thoughts, lifestyle and schedule, as well as your overall sleep score.

When ready to sleep, Le Profe is back and suggesting a series of thoughts and

> mechanisms to help you fall asleep, each witth different levels of difficulty.

> Le Profe r e c o m m e n d s anything from keeping all lights off at night to

making sure you only sleep a certain number of hours every night.

Sleepio helped me determine

exactly what kind of issues might be negatively affecting my sleeping schedule. But, it did not put me to sleep the way I thought it would after reading the app

descriptions and answering all the determining questions and promising statistics.

I expected to be having the best sleep of my life, but Sleepio seemed to be more work than reward.

After his stellar opening performance of "Piano Man" by Billy Joel, Hakwoo gave some insight how it felt to sing first


in a situation most people don't volunteer for.

# MOVIE REVIEW: "Gone Girl" must-see

"Gone Girl", directed by David Fincher and based on the best-selling novel by Gillian Flynn, is a story about the complexities of people and of marriage. Nick (Ben Affleck) and Amy Dunne (Rosamund Pike) were seemingly happily married for five years, but after Amy disappears on their fifth anniversary, the world is left wondering why? With mounting evidence pointing to Nick and his stream of lies causing massive suspicion, the question of the movie becomes: Did Nick kill his wife?

Through Nick's personal thoughts as well as fragments of their past shown through Amy's journal, the audience begins to see their marriage for what it really is; not only one of love and happiness, but also one of struggle and secrets. Director David Fincher is well known for his dark thrillers, including highly successful movies such as "The Girl with the Dragon Tattoo" and "Fight Club." His dark and intelligent

style paired with the already captivating storyline of the book makes for a movie that is as disturbing as it is thrilling.

Also attributed to his directing style are the mesmerizing performances put forth by leads Affleck and Pike. Affleck's past includes a series of hit or miss films, some receiving scalding criticism and some winning Oscars, but it seems Fincher knew just what to bring out in Affleck as "Gone Girl" is one of his most convincing roles yet.

The energy between Affleck and Pike is the perfect mix of tension and attraction that the movie calls for, sucking the audience in and yet horrifying them all at once.

A chrilling soundtrack by Trent Reznor and Atticus Ross, who collaborated to win the Best Original Score academy award for "The Social Network" (2010), only adds more dimension to the dark tone. "Gone Girl" is a story full of twists and turns, of romance and mystery and of trust and deceit. It is the definite must-see movie of this year.

For the rest of the second half De Anza kept control of the ball, completed most of their passes, and stopped Las Positas from making a comeback.


De Anza head coach Rusty Johnson said he was satisfied with the way his team played especially because it was their first tough game of the season.


